## Candidate Profile Statement - for the National Board of YHA New Zealand

Profile statements should be provided by email to the Returning Officer, Warwick Lampp, [nominations@electionz.com](mailto:nominations@electionz.com), with the nomination form by the close of nominations, **12 noon Friday 13 September 2019**.

**Candidates should refer to the Candidate Handbook for the required specifications for the following documents:**

- Candidate profile statement of no more than 300 words, which may cover:
  - Occupation, business expertise, management experience
  - Community and other interests
  - A comment on the role and function of YHA New Zealand
  - A comment on the role and function of the Honorary Vice-President of YHA New Zealand
  - The contribution you believe you could make as a Honorary Vice-President
- A Conflict of Interest Statement and Statutory Declaration.
- It is recommended that candidates include a recent black and white passport size photo with the profile statement. Photos should be scanned as a jpeg/jpg file at a minimum of 300 dpi and emailed to [nominations@electionz.com](mailto:nominations@electionz.com).

## Guidelines for Board Members Conflict of Interest Statements

When lodging a nomination with the Returning Officer, candidates for election to the Board are required to provide a statement of their current and any likely future conflicts of interest - list any commercial interests you have which may conflict with the mission/goals of YHA New Zealand.

The requirements for disclosure of Board Member Interests are set out in Clause 12.5 of the YHA New Zealand Constitution. All candidates must familiarise themselves with the requirements of Section 12 of the Constitution prior to submitting their Nomination Paper (refer to page 14 of the candidate handbook).

**If a candidate does not provide a Conflict of Interest Statement at the time of nomination, he/she may be disqualified from standing for the Board.**

## Privacy Statement
